**Cancellation Policy (see separate fees below): (1) Cancellations must be submitted in writing via email, fax or mail and received by PIA of Florida prior to the class. (2) No "credits" granted, only specified transfers or refunds. (3) No transfers may be carried into another calendar year. (4) When you notify us of your cancellation you must specify what class you want to transfer into or we will generate a refund. (5) You may substitute an eligible person for the same class with prior notification/approval.**

**3-Day Institute Cancellation Fees: (1) Cancellations received within 14 days prior to a institute or within 7 days prior to a Graduate Seminar incur a \$75 fee. (2) If you do not cancel and do not attend, you will incur a \$125 fee. (3) Failure to request a refund or transfer within 30 days after the class constitutes forfeiture of your registration fees**

**1-Day Classes: (1) Cancellations received within 7 days prior to the class incur a \$25 fee. (2) If you do not cancel and do not attend, you will incur a \$50 fee. (3) Failure to request a refund or transfer within 30 days after the class constitutes forfeiture of your registration fees**

**Other Classes not listed above: (1) Cancellations received at least two days prior to a class receive a full refund. (2) If you do not cancel and do not attend, you forfeit your fees.**
